- 4. Calibration status label to be pasted on instruments properly with water resist transparent sheet.
- 5. Any Off site (instrument Calibration in Lab) calibration of instrument / standard weights pick-up and delivery charges to be include and return within 4 days.
- 6. For Calibration of Weighing balance, standards weights to be provided by vendor with valid traceable certificate.
- 7. Suitable master calibration instrument to be used for calibration and set of certificate to be produced before calibration.
- 8. The instrument taken for calibration to be handling carefully (both on site and off site) and if any damages during calibration to be replaced be the vendor on free of cost.
- 9. If the instrument is already damaged before calibration need to be informed early to KAPL E&P dept. concern person.
- 10. Instrument removing and re-fixing for calibration will be done by vendor.
- 11. Original Calibration certificate to be file properly with box file and sheet protector for individual set of instrument and submit within a week from date of calibration.
- 12. The billing should be charged on actual Quantity only.
