**AMC TERMS AND CONDITIONS**

**Preventive maintenance visit**

**I. Standard A check service**

- Check oil level in the diesel generator and top-up the oil if required.
- *Check and clean of diesel generator sets.*
- Check battery voltage.
- Check for any type of leakage.
- *Check all filter condition.*
- Check coolant level, top-up the coolant if required.
- Check the condition v-belts.
- Check the engine working condition and recommend the required spares for service.
- *Service report / check list to be given after completion of work on each visit.*
- Check Turbo Charger, Alternator, DG main panel.
- Run the DG set for 5-10 min and observe the any abnormality in the engine.
- *Check the AMF panel working condition and need to clean the electrical parts.*
- Check the AMF panel relay, contactor, ACB with motor and timer.

**II. Standard B-check service maintenance (all Spares will be given By KAPL)**

B Check Service (Every 250 Hrs. of engine operation / 6 months once whichever is earlier)

- Change lubricant engine oil
- Change oil filter, fuel filter, and bypass filter
- Change air filter
- Change water separator
- Radiator cleaning with chemical
- Change the radiator coolant
- Radiator belt replacement if required
- Radiator and Lube oil Hose pipe replacement if required
- Recommend the required spares for service





**Note:** AMC does not cover Overhauling, Rewinding, Spares, outside work, Accessories repair, Panel wiring, any modification, Major repair works (engine repair work, alternator...Etc).

Recommendation spares for next service to be given in advance.

Service report and check list shall be given by vendor after completion each service.

There should be adequate number of Telephone lines for lodging of service requests. If the AMC Provider firm failed to attend the calls within 24 hours, KAPL reserves the right to get the work done by other firms and deduct such expenses from the AMC charges. In the Case of exceptional and repeated delays, poor services, fault, break down, etc, this office reserves the right to deduct such costs as deemed to be necessary by way of damages and may also cancel the AMC unilaterally.

Only experience engineers/technicians/mechanics helpers, whose character and antecedents have already been verified, will be deputed to attend the work.
